Original clause

He shall have the casting vote and shall sign all minutes of each meetings at the time they are approved. He shall in conjunction with the Secretary and Treasurer sign all cheques on behalf of the society."

Rule 9 (3) " The Secretary shall conduct the business of the Society in accordance with the rules and shall carry out the instructions of the general meeting and of the committee. He shall be responsible for conducting all correspondences and keeping all books, documents and papers except accounts and financial records. He shall attend all meetings, and record all proceedings. He shall keep membership register consisting details such as names, identity card number, date and place of birth, occupation, name and address of employer and residential address. He shall in conjunction with the President and Treasurer sign all cheques on behalf of the Society. He shall file annual returns within 60 days from the date of the annual general meeting to the Registrar of Societies as required under Section 14(1) Societies Act, 1966."

Rule 9 (5) "The Treasure shall be responsible for the finances of the Society. He shall keep accounts of all its financial transactions and shall be responsible for their correctness. He shall in conjunction with the President and the Secretary sign all the cheques on behalf of the Society."

Rule 10 (3) " All cheques or withdrawal notices of the Society's account shall be signed jointly by the President, the Secretary and the Treasurer. In the absence of the President, the Secretary or the Treasurer for a long period, the Committee shall apooint one of its members to sign in his place."

New clause

Rule 9 (1) "The President during his term of office presides at all general meetings and all meetings of the committee and shall be responsible for the proper conduct of all such meetings. Rule 10 (3) " All cheques or withdrawal notices of the Society's account shall be signed jointly by the President, with the Secretary or Treasurer. In the absence of the President, the Secretary or the Treasurer for a long period, the Committee shall appoint one of its members to sign in his place."
